

**Petition to Amend Forest Ridge Covenants

A special committee of 6 volunteer homeowners and 3 FRHOA board members has proposed the following addition to the FRHOA Covenants to help preserve the unique natural beauty and property values of our community. A minimum of 75% of the Homeowners in the community must agree to the proposed change to pass. Only one signature per household is allowed. Please sign below to agree to the provisions. **The proposed addition to the covenants shall read:  
Article VII, number (11) as presented on August 4, 2005**

**To preserve the unique natural beauty of the Forest Ridge Community, as well as enhance individual and collective property values, no tree 8 inches or more in diameter (25.125 inches in circumference) measured at 4.5 feet above the ground is to be removed without prior written approval from the Board of Directors or the Architectural Control Committee.**

**Approval will generally be granted for dead, diseased, or endangering trees, or as necessary or appropriate for improvements, such as pool, garden, or deck. The Board of Directors or the Architectural Control Committee will work with the property owner to evaluate and approve trees to be removed. The specific tree(s) requested to be removed must be individually marked or flagged on the lot so they can be identified by the Board of Directors or the Architectural Control Committee as part of their review and evaluation process. In all cases, the property owner will accompany the Board of Directors or the Architectural Control Committee member during this on-site inspection.**

**Board of Directors or the Architectural Control Committee may require a suitable replacement for any tree removed without prior written approval.**
